Team size can vary from 5 to 10 which also includes SHG members and they have to give their social venture a suitable, relevant name which be the reference for registration if selected in the audition round. Regarding the governance & compliances Selected teams will have to essentially go through all the stages and comply with the suggested protocols as shared in the information brochure and notices that will be shared from time to time pertaining to each stage and submit their prototype ,POC and performance report as asked for, any team not complying will be delisted from the program and evaluation. Regarding Prizes:

The certificate /memento /trophy awarded during the Felicitation Function is symbolic. The certificate and trophy will bear the name of the Team as entered during the registration (Audition selection).Certificates of all other selected teams (participants) will be mailed to the contestants by the college co-ordinators.
